- 1) To provide a safe and productive activity within Liberty Hose Company for the youth of Lykens.
- 2) To promote public safety/awareness to the youth of Lykens.
- 3) To provide training and experience enhancing the future membership of the company.

APPLICATION / ACCEPTANCE PROCESS

- 1) All applicants must be age 14 to 17.
- 2) The applicant shall complete a membership application, provide working papers, submit membership fees, and have written consent from the parent or legal guardian.
- 3) The applicant shall be subject to the same interview process as with regular membership consideration. During this interview the parent or legal guardian must be present.
- 4) Once accepted into the company, the junior member shall possess the same membership rights and responsibilities as regular members, with the exception of voting rights during the election of officers.

RULES AND REGULATIONS

- 1) Any violation of the rules and regulations of the company will be grounds for disciplinary action as directed by the company.
- 2) Any junior member may be suspended from activity at the request of the parent or legal guardian for any reason. The parent or legal guardian must submit in writing to any chief the request for this action. Suspensions may be repealed, but only with parental or guardian consent.
- 3) Any junior member failing to maintain an acceptable grade average will be suspended until the grade average is acceptable. An acceptance grade average will be determined by the parent or guardian and the line officers at the time of acceptance. Rule number two applies anytime.
- 4) Junior members may respond to alarms between the hours of 0600 - 2400. If an alarm carries over past 2400, the junior must notify the officer in charge. Upon returning to the station from a carried over alarm, junior members are to report directly to their residence. There are NO EXCEPTIONS.

JUNIOR FIREFIGHTER

- 5) On school nights junior members may not remain on property of Liberty Hose Company No 2 after 2100. On non-school nights junior members must vacate company property at 2300. With the exception of fire company meetings, the Hose Company Club is off limits at all times.
- 6) No junior member shall be under the influence or in the possession of any intoxicating or illegal substance while on company property.
- 7) AT NO TIME will a junior member don a self contained breathing apparatus, enter a hazardous environment or burning structure, ascend or descend a ladder, operate any mechanical equipment (including fire apparatus), or occupy a position on the platform of Truck 22. The role of the junior firefighter will be determined by the officer in charge. Junior firefighters will remain with the apparatus operator unless directed otherwise by an officer.
- 8) AT ALL TIMES the junior firefighter will don complete protective clothing (helmet, coat, pants, boots, and gloves) unless directed otherwise by the officer in charge. Helmets will be clearly marked "Junior Firefighter."
- 9) Junior members will not be eligible for "blue light" authorization.
- 10) Junior firefighters are to follow the direction of Company 22 line officers or the officer in charge.
