Social Membership

The purpose of the Social Club is to provide for the social well being of the members of the Company, who are associated together not for profit, for the legitimate purpose of mutual benefit, entertainment, fellowship, or lawful convenience, having the fire service as a primary interest and activity to which the sale of food and alcohol shall be only secondary.

RULES:

1. **Social Members must be at least twenty-one (21) years of age.**
2. With the exception of functions that are open to the public, **Social Members may not bring any guests** into the social quarters.
3. **Social Members** may not attend and **have no voting rights** at any company meeting.
4. **Social Members must obey all rules** of the social quarters.
5. All disciplinary action will be directed and approved by the Board of Directors of Liberty Hose Company No. 2.
6. Social Membership **dues run from February 1 to January 31.**
7. A Social Member not paying his/her dues **within one year of becoming delinquent will lose his/her membership** and must reapply for membership if desired. Delinquent dues **must** be paid on the social member's first club visit within a year after becoming delinquent. Delinquent social members are not eligible for any rights or benefits of social membership.
8. **Social members may not sponsor anyone for membership.** Only an Active Member may sponsor someone for membership.
9. **The membership key** issued to a social member **remains the property of Liberty Hose Company No. 2.** It is non-transferrable **and must be returned to Liberty Hose Company No. 2 upon termination of membership** for any reason..
10. The application fee includes the first year's dues of the applicant, if he or she is approved. **The application fee is nonrefundable.**
